

Matched Giving Schemes

Bolingbroke PA is a registered charity. Volunteers for Bolingbroke PA have therefore been able successfully to apply for matched funds through their employer matching schemes.

Many companies will help support charities through a matched giving scheme, whereby they will match gifts donated by their employees, funds raised through the employees efforts or sometimes gifts in kind. Some companies have formal schemes for matched funding, while others may consider each request on its own merits. In some cases, participating companies will match an employee's donation pound for pound up to a set amount or even double-match.

Below is a list of companies which we understand will match the charitable gifts of their employees. It may not be up to date. In each case you should check with your employer the specific terms and conditions which apply.
